**Draft VILLAGE OF MAMARONECK COMMITTEE FOR THE ENVIRONMENT  
MINUTES OF March 15, 2022 MEETING**

Members Present: Ellen Silver (Chair), Lou Young (Village Trustee), Christi Young, Mandy Forlenza Sticos, David Freeman, Dan Kushnick, Liam Robb O'Hagan, Katherine Dehais, Renee Crabtree, Debbie Sullivan.

Members Absent: Tim Whitney.

The meeting was held via Zoom and was called to order at 7:05 pm.

### **General Discussion**

The minutes of the Committee's February 15, 2022 meeting were approved.

Ellen announced that LED light bulbs were purchased with some of the \$5000 CEC campaign grant money. The Larchmont-Mamaroneck Task Force distributed them with a bilingual flyer that explained the energy savings benefits of the bulbs at this past week's food distribution. Remaining bulbs will be distributed again next week.

Ellen brought up a letter writing campaign started by a Mamaroneck School District parent to promote transitioning to the use of diesel gas powered school buses with electric ones in the upcoming budget. She will send out a sample letter to send to Dr. Shaps for anyone who is interested.

### **Healthy Yards**

Mandy opened a discussion about a Mamaroneck Library Author Event to promote Monarch awareness. She and Ellen have spoken to Library staff about organizing a Zoom event with author Ann Hobbie. It was decided that it would be best hold the event in the fall. Ellen and Mandy will follow up with the Library.

Ellen asked for ideas for slogans for the Litter Awareness Campaign. She wants to kick off the campaign with the May 7 Clean and Green. Christie suggested that we have multiple slogans. We discussed the use of metal or vinyl signs and to have signage on trash cans. David brought up the placement of household trash in bins as a problem. Lou stated that this is an on-going problem and should be addressed with violations rather than prevent the placement of additional bins. Ellen asked about the scheduling of pickups of trash from community bins. Lou will follow up to find out how pickups are scheduled. He suggested that the Committee be very specific about placement of the bins, signage in communicating with the Village.

The leaf blower ban starts May 15th. Enforcement has been an issue in the past. Ellen will raise the issue with Jerry Barberio about the law and enforcement. Mandy will add a firefly graphic to our website to further encourage families to avoid destroying their habitat. Last year the Village put door hangers out explaining the law and the harm that leaf blowers inflict. Ellen raised the possibility of LED signage to promote the law.

### **Community Engagement**

The Clean and Green is scheduled for May 7. The zones will include riverbeds, less emphasis on Harbor Island which gets cleaned regularly. Free compost will be given away. The Marine Education Center will be collaborating. Robert Ingenito will do a flyer about the event. Mandy raised the issue of teenagers being more closely supervised.

Ellen and Mandy will be attending the Central Avenue School Earth Day on April 22 from 3-4.

**River Maintenance** will be discussed more fully once we know the status of the grant application for the Pollinator Pathways project.

### **Clean Energy Communities/Climate Smart Communities update**

Ellen and Dan attended a Sustainable Westchester webinar on Building Decarbonization and Advancing Clean Energy Codes which discussed the NY Stretch Code. The mayor of New Rochelle spoke to endorse the code. Buildings account for 1/3 of all carbon emissions in NY State.

Liam and Ellen opened a discussion of the NYStretch Code which they are both in favor of the Village adopting. If the Village adopts it by June 2022, we can apply for a \$5000 grant. The code will be a NY state law in a few years. David asked about building cost increases associated with the code. Liam stated that, according to Sustainable Westchester, additional costs are made up in 6.4 years in energy cost savings for residential buildings, and in 3-13 years for commercial spaces. After further discussion, a resolution was passed unanimously to recommend that the Board adopt the NYStretch Code. Lou will bring it to the next work session (2 weeks). Liam will see about having NYSERDA present at the next Trustees meeting (3/24/22).

Ellen reported that Jeff Ahne of the Parks department is enthusiastic about transitioning to electric equipment. There is about \$6200 left from the CEC campaign grants which will be put toward an electric mower. Ellen would like to see the Village have an AGZA Green Zone once we get equipment.

A discussion was opened about a Village rooftop installation. Lou recently visited the Town of Clarkstown where they have a pollinator/solar combination on a landfill. The possibility of different sites in the Village were discussed including Taylor's Lane. The Committee agrees that we support any action on solar that the Village undertakes.

Jerry Barberio sent Ellen an inventory of the village fleet. There are not a lot of electric vehicles. She will follow up to get all the information that is needed for CSC credit.

### **Food Scrap Recycling**

The Village started a pilot program of food scrap pick up. Two DPW workers pick up using a flatbed truck. Ellen and Liam accompanied them for part of the first day. Two hundred and eight households participated; now there are 222 signed up. On the first day, pick-up had to be continued on the following day. They have now asked that the containers be placed closer to the curb to save time. Ellen stated that it is important to continue with data collection, and has asked how this is being done. It has to be clarified how questions about the program need to be fielded.

## **No Mow May**

Mandy states she will put an announcement on our Facebook and Instagram pages about No Mow May, a program to encourage leaving lawns unmowed to protect insect populations.

The meeting adjourned at 9:00 pm
