Old Business:

Maintenance Update:

 Correspondence with Jeff Ahn. High rate of tree deaths on newly planted trees, some after the gator bags. Watering started late, very dry summer. James has asked for an additional worker for next year to assist in watering of trees/plants.

Tree Law Update:

- Tree damage at Harbor Island Tupelo due to grass trimming – lets plant Allegheny Spurge or something like "Plantra trunk saver mower, trimmer guard" or other trunk guards that can be removed after a few years. OR immediately mulch after planting to create safe circle surrounding tree.

302 Hunter on Rose Lane — Bradford pear tree, leaning over street (ConEd), dropping limbs, decay (removal)

641 Halstead on N. Barry — dead tree (removal)

1102 Keeler Street — dead branch near powerline (pruning)

540 & 550 Lawn Terrace — 3 London planes, mold/fungus (fuzzy) on multiple leaves (treatment needed)

236 Melbourne (ROW) — tree needs to be inspected; dying new tree (removal)

320 Melbourne — dead crabapple tree (removal)

100 Sheldrake Place — ROW trees blocking sidewalk, encroaching on patio space (pruning/clearance)

1040 Seven Oaks Lane — three new cherries, decay at bottom (inspection)

811 Shore Acres Drive (across the street) — prune overhanging dead branches; prune dead wood from young tree (pruning)

734 Guion Drive on S. Barry (sidewalk side) — formerly healthy, tree suddenly dying (inspection)

424 Tompkins — dead central limbs, fungus growing from trunk base (removal)

588 The Parkway, median — mature cherry, decay at bottom (inspection)

Corner of N. Barry on Carvel's sidewalk — dead tree (removal)

Attachment 6 VOM Budgets for Seasonal Pruning and Reforestation

Good Morning,

This is the budget over the last 5 years for the Shade Trees. In 2022-23 the Village Manager increased the appropriation for Tree Reforestation from \$30,000 to \$60,000, which was then reduced in the subsequent year. (NOTE: reduced to \$40,000)

Also, in 2022-23 an appropriation was added for \$42,000 for seasonal Pruning of large trees. Is this the allocation you are referring to? The \$42,000 has remained constant over the last 4 years. Yes, DPW is responsible for the tree maintenance in the Village and Parks the purchase and planting.
