

## **Declaration of a Local State of Emergency**

Kathleen Gill, Village Manager of the Village of Mamaroneck, County of Westchester, State of New York, pursuant to the power vested in her by the laws of the State of New York, including Section 24 of the New York State Executive Law to preserve the public safety and render all required and available assistance vital to the security, well-being and health of the citizens of Mamaroneck, hereby exercises that authority and declares as follows:

WHEREAS, as of February 21, 2026, a public disturbance of an anticipated significant snowfall exists, with a projected snowfall total of 12 to 18 inches, Sunday afternoon, February 22, 2026, into Monday, February 23, 2026, posing an imminent danger to public transportation, public health, and public safety systems within the Village of Mamaroneck; and

WHEREAS, this significant, dangerous public disturbance is expected to continue and pose a threat to the public transportation, public health and public safety of the Village of Mamaroneck and its citizens;

IT IS HEREBY ORDERED that a Local State of Emergency relative to this public disturbance is declared and exists in the Village of Mamaroneck effective at 12:00 p.m. on February 22, 2026; and

IT IS FURTHER ORDERED, that this State of Emergency will remain in effect for five (5) days, or until rescinded by a subsequent order, whichever occurs first.

# EXECUTIVE ORDER

Number 2 of 2026

## Local Emergency Order No. 2

KATHLEEN GILL, Village Manager of the Village of Mamaroneck, County of Westchester, State of New York, pursuant to the power vested in her by Section 24 of the New York State Executive Law and the laws of the State of New York does hereby order and declare as follows:

WHEREAS, Section 24 of the New York State Executive Law authorizes the chief executive officer of a village, pursuant to a declaration of a local state of emergency, to issue orders to preserve the public safety, well-being and health of such city in times of emergency; and

WHEREAS, the Village of Mamaroneck declared a local state of emergency, effective February 22, 2026, due to an anticipated significant snowfall event Sunday afternoon, February 22, 2026, into Monday, February 23, 2026, posing an imminent danger to public transportation, public health, and public safety systems within the Village of Mamaroneck; and

WHEREAS, pursuant to Vehicle and Traffic Law § 1602, whenever the chief executive officer of a village shall deem it advisable during a snow storm or in order to remove snow or to plow streets, such chief executive officer may close any street or part thereof to vehicular traffic or prohibit, restrict or limit the stopping, standing or parking of vehicles;

NOW, THEREFORE be it


ORDERED, that upon the commencement of snowfall during the effective period of this Executive Order, a snow emergency is declared, and the parking of vehicles shall be prohibited on the snow emergency streets as set forth in § 326-88.2 of the Code of the Village of Mamaroneck, and set forth below, in order to remove snow and to plow streets:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Boston Post Road, East (U.S. Route 1)	Both	Entire length from City of Rye border to Mamaroneck Avenue
Boston Post Road, West (U.S. Route 1)	Both	From Mamaroneck to Rockland Avenue
Fenimore Road	Both	From Town of Mamaroneck border to Palmer Avenue
Halstead Avenue	Both	Entire length from Town of Harrison border to Mamaroneck Avenue

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Mamaroneck Avenue	Both	Between Boston Post Road and the I-95 Overpass
North Barry Avenue	West	From First Street to East Boston Post Road (U.S. Route 1)
Palmer Avenue	Both	Entire length from Town of Mamaroneck Border to Mamaroneck Avenue
Top of the Ridge	South	From the east side of the driveway entrance at 25 Top of the Ridge to a point 60 feet northeast along the west cul-de-sac
Top of the Ridge	North	From a point 80 feet northeast of the east side of the driveway entrance at 61 Top of the Ridge to a point 80 feet northeast along the east cul-de-sac; and be it further

ORDERED, that this emergency order shall be effective at 12:00 p.m. on February 22, 2026, and shall remain in effect for five (5) days unless extended, rescinded or modified in accordance with Executive Law § 24 (2).
