STEPHEN E. JOHNSTON BEACH RULES

Hours of Operation

- Beach is open Monday through Sunday from Memorial Day to Labor Day.
- Beach is open for swimming from 9:00 a.m. until 5:30 p.m.
- Beach restrooms close at 5:30 p.m.
- Spray ground hours of operation are from 10:00 a.m. until 5:30 p.m.
- Beach will be closed on July 4th for Independence Day holiday celebrations (rain date July 5th).
- In the event of heavy rain, the beach may be closed for swimming as ordered by the Westchester County Health Department.

Beach Rules and Regulations

- Beach pass must be presented with photo ID. Beach pass is non-transferrable; the lending of your pass is subject to a loss of beach privileges.
- Lost beach pass is a \$5.00 replacement fee.
- Children under 13 must be accompanied by an adult and be actively always supervised on the beach, spray ground and waterfront.
- Swimming permitted only in designated swim areas.
- Ball & frisbee playing permitted only in upper beach area.
- Inflatable devices must be U.S. Coast Guard approved.
- Beach umbrellas and beach tents must be properly secured.
- If thunder or lightning occur, beach patrons must immediately exit when instructed by lifeguards or staff.
- No refunds will be provided in any circumstance.

The Following Are Prohibited:

- Swimming with no lifeguard on duty.
- Dogs or animals (documented service animals are permitted).
- No solicitation.
- Glassware, glass bottles, barbecuing, radios, diving, smoking.
- Alcoholic beverages (containers, coolers, beach bags, backpacks are subject to inspection).
- Launching watercraft from beach.
- No fishing.

HARBOR ISLAND PARKING RULES

Hours:

- Parking is permitted in Harbor Island Park from 6:00 a.m. to 10:00 p.m. daily.
- Seasonal parking permit or daily parking ticket is required from the Friday before Memorial Day through Labor Day.
- Daily fees enforced Monday thru Friday 8:00 a.m. to 8:00 p.m. and Friday thru Sunday 6:00 a.m. to 8:00 p.m.

Seasonal Parking Permits:

- Seasonal parking permits can be purchased at the Recreation Department during normal business hours Monday through Friday from 9:00 a.m. to 4:00 p.m.
- Parking permit should be affixed on rear view mirror. Motorcycles and Jeeps should place the parking permit in a visible location.
- The replacement of a lost or stolen seasonal parking permit will need to be repurchased at the Recreation office at full price.

Restrictions:

- General (non-boater permit) parking is prohibited in boat & trailer parking spaces & East basin MP lot adjacent to the boat ramp.
- Seasonal parking permit is non-transferable to other vehicles. License plate on permit that does not match license plate number on vehicle may result in a parking ticket.
- Overnight parking or camper lodging is not permitted in Harbor Island Park.
- Improperly parked vehicles may be removed; cost of removal will be charged against the individual in whose name the vehicle is registered.
- Purchase of a seasonal parking permit does not guarantee a parking space.
- Always secure your vehicle when you leave it unattended. You are parking at your own risk and the Village of Mamaroneck is not responsible for any theft, vandalism or damages done to your vehicle while parked in Harbor Island Park.
